EXPLANATORY NOTE

The Philippines stands out as East Asia's Biggest dog owner, with six times the per-capita number of pets seen in china. In the Philippines, there one pet dog for every 8 people. While cats on the other hand occupy the second most popular animal in the Philippines. From these date provided, it is quite clear that the Philippines is a pet-loving country. It can be understood as why the Philippines is a pet-loving country as numerous studies show that pets reduce stress, anxiety, and depression, ease loneliness and provide valuable companionship. With the emergence of pet-friendly public places today, especially malls, it only suitable that pet owners are allowed to bring their pets in public utility vehicles.

As pet owners consider their pets as important members of their families, it is understood that pet owners are motivated to provide love, care and devotion for their pet. The passage of this bill limit the unfortunate occurrence of having to leave pets at home just because of issues in transportation. Likewise, promotion of the pet's welfare will also come into play as the passage of this Bill will make it easier for pet owners to bring their pets around different places which in turn contributes in their pets' physical, social, emotional and mental well-being.

This bill intends to allow pet-owners to bring their pets in PUVs. It further mandates PUV owners to provide designated animal compartments in order to accommodate said animals.

**AN ACT ALLOWING PETS TO BE TRANSPORTED IN PUBLIC
UTILITY VEHICLES OPERATING IN THE PHILIPPINES**

Be it enacted by the Senate and House of Representatives of the Philippines on Congress assembled:

SECTION 1. Short Title. – This Act shall be known and cited as the “Pet Transport Act”.

SECTION 2. Declaration of Policy. – It shall be the declared policy of the State to harmonize the policies of public of transport and the provisions enshrined in the Animal Welfare Act in order to promote and uphold animal welfare in the Philippines.

SECTION 3. Coverage. – This Act shall apply to all public vehicles (PUV) operating in the Philippines.

SECTION 4. Transport of pets in PUVs. – Owners of pet shall be allowed bring their pets in PUVs provided that the following are observed:

- a) The animals are put inside carriers/cages and placed at the designated animal compartment of the PUV, should there be other passengers inside the PUV;
- b) If there are no other passengers, pet may be allowed to be carried by the owner as long as said animals are free from foul odor and that the owner maintains cleanliness and sanitation.
- c) The possessor or pet owner shall make sure that his or her pet does not cause any damage in the PUV which includes but is not limited to cleaning and sanitation of the PUV and safety of the other passengers. Should the pet cause any harm or damage in the PUV, the possessor or pet owner shall be made liable for the damage caused;
- d) Safety, convenience and comfort of the passengers shall not in any way be sacrificed.

SECTION 5. *Designated animal compartments* – Every PUV operating in the Philippines shall be required to provide a designated animal compartment where pet owners may leave the animals while in transit in the PUV. No cruel confinement or restraint shall be made on such animals while being transported.

SECTION 6. *Implementing Rules and Regulations* – Within sixty (60) days from the promulgation of this Act, the implementing rules and regulations for the proper implementation of its provisions shall be formulated by the appropriate the government office or agency in coordination with all the stakeholders and covered establishments and institutions.

SECTION 7. *Separability Clause*. – If any provision of this Act is declared unconstitutional or otherwise invalid, the validity of the other provisions shall not be affected thereby.

SECTION 8. *Repealing Clause*. – All laws, decrees, orders, rules and regulations or parts thereof inconsistent with Act are hereby repealed or modified accordingly.

SECTION 9. *Effectivity*. – This Act shall take effect fifteen (15) days after its publication in the Official Gazette or in a newspaper of general circulation.
