AN ACT
DECLARING APRIL 28 OF EVERY YEAR A SPECIAL WORKING HOLIDAY IN THE PROVINCE OF AURORA TO COMMEMORATE THE DEATH ANNIVERSARY OF DOÑA AURORA ARAGON-QUEZON

*Be it enacted by the Senate and the House of Representatives
of the Philippines in Congress assembled:*

1 **SECTION 1.** April 28 of every year is hereby declared a special working holiday in the
2 Province of Aurora to commemorate the death anniversary of Doña Aurora Aragon-Quezon.

3 **SEC. 2.** The local government of the Province of Aurora shall plan and implement
4 appropriate ceremonies for the annual observance of the Death Anniversary of Doña Aurora
5 Aragon-Quezon.

6 The *Sangguniang Panlalawigan* of the Province of Aurora shall appropriate Five hundred
7 thousand pesos (P500,000.00) annually to carry out the objective of this Act. The amount may be
8 periodically increased to a reasonable level depending on certain economic factors prevailing in
9 the country.

10 **SEC. 3.** This Act shall take effect fifteen (15) days after its publication in the Official
11 Gazette or in a newspaper of general circulation.
