HOUSE BILL NO. 7529

Introduced by Representative Fernando T. Cabredo

**AN ACT
DECLARING THE MUNICIPALITY OF JOVELLAR IN THE PROVINCE OF ALBAY
AN ECOTOURISM ZONE AND APPROPRIATING FUNDS THEREFOR**

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** The Municipality of Jovellar in the Province of Albay, famous for its
2 Sigpit/Quitinday Falls and underground river and caves, is hereby declared an ecotourism zone.
3 As such, its development shall be prioritized by the Department of Tourism (DOT), subject to
4 the rules and regulations governing the development of ecotourism zones.

5 **Sec. 2.** Within one (1) year after the approval of this Act, the DOT, in coordination with
6 the municipal government of Jovellar, the Representative of the Third Congressional District of
7 Albay and other concerned agencies of the government, shall prepare a tourism development
8 plan containing, among others, the construction, installation and maintenance of such appropriate
9 facilities and infrastructure that shall encourage tourism in the area: *Provided*, That said
10 development plan shall ensure the preservation and conservation of the natural beauty and the

1 indigenous flora and fauna therein. Further, the development plan shall include the formulation,
2 development and implementation of programs and strategies that will generate livelihood and
3 employment opportunities for the residents in the area.

4 **Sec. 3.** The DOT shall take immediate steps to implement the development plan and
5 incorporate the same in its tourism development program for the ensuing calendar year. It shall
6 also include the Municipality of Jovellar in all its national, regional and local promotion
7 programs.

8 **Sec. 4.** The Secretary of the DOT shall include in the Department's program the
9 implementation of this Act, the funding of which shall be included in the annual General
10 Appropriations Act and from internally generated funds of the DOT.

11 **Sec. 5.** All laws, rules, regulations, proclamations, executive orders or parts thereof
12 inconsistent with this Act are hereby modified or amended accordingly.

13 **Sec. 6.** This Act shall take effect fifteen (15) days after its publication in the Official
14 Gazette or in a newspaper of general circulation.
