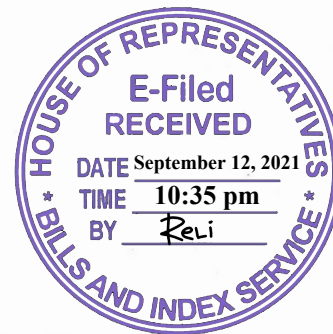

AN ACT

SEPARATING THE MARCELO GREEN HIGH SCHOOL (PARANAQUE NATIONAL HIGH SCHOOL ANNEX) IN BARANGAY MARCELO GREEN, CITY OF PARANAQUE, FROM THE PARANAQUE NATIONAL HIGH SCHOOL, CONVERTING IT INTO AN INDEPENDENT NATIONAL HIGH SCHOOL TO BE KNOWN AS MARCELO GREEN NATIONAL HIGH SCHOOL AND APPROPRIATING FUNDS THEREFOR

AN ACT

SEPARATING THE PARAÑAQUE NATIONAL HIGH SCHOOL – MARCELO GREEN ANNEX IN BARANGAY MARCELO GREEN, PARAÑAQUE CITY, METRO MANILA FROM THE PARAÑAQUE NATIONAL HIGH SCHOOL, CONVERTING IT INTO AN INDEPENDENT NATIONAL HIGH SCHOOL TO BE KNOWN AS THE MARCELO GREEN NATIONAL HIGH SCHOOL, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. The Parañaque National High School – Marcelo Green Annex in Barangay
2 Marcelo Green, Parañaque City, Metro Manila is hereby separated from the Parañaque National
3 High School and converted into an independent national high school to be known as the Marcelo
4 Green National High School.

5
6 SEC. 2. All personnel, assets, liabilities and records of the Parañaque National High School
7 – Marcelo Green Annex are hereby transferred to and absorbed by the Marcelo Green National
8 High School.

9
10 SEC. 3. The Secretary of Education shall immediately include in the Department’s program
11 the operationalization of the Marcelo Green National High School, the initial funding of which
12 shall be charged against the current year’s appropriation of the Parañaque National High School –
13 Marcelo Green Annex. Thereafter, the amount necessary for the continued operation of the school
14 shall be included in the annual General Appropriations Act.

15
16 SEC. 4. Within sixty (60) days after the approval of this Act, the Secretary of Education
17 shall promulgate the rules and regulations implementing the provisions of this Act.

18
19 SEC. 5. This Act shall take effect fifteen (15) days after its publication in the *Official*
20 *Gazette* or in a newspaper of general circulation.
