ACT STRENGTHENING PROFESSIONALISM AND PROMOTING THE  
CONTINUITY OF POLICIES AND MODERNIZATION INITIATIVES IN  
THE ARMED FORCES OF THE PHILIPPINES, BY PRESCRIBING  
FIXED TERMS FOR KEY OFFICERS THEREOF, INCREASING THE  
MANDATORY RETIREMENT AGE OF GENERALS/FLAG OFFICERS,  
PROVIDING FOR A MORE EFFECTIVE ATTRITION SYSTEM, AND  
PROVIDING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1 TITLE I

2 DECLARATION OF POLICY

3 SECTION 1. *Declaration of Policy.* – In pursuit of modernization of the Armed  
4 Forces of the Philippines (AFP), it is hereby declared the policy of the State to:

5 (a) Enhance professionalization in the organization by strengthening the merit  
6 system, allow the new leadership a longer period to implement reforms, and  
7 institutionalize sound policies that will redound to the improvement of the AFP;

8 (b) Promote the most qualified officers to higher ranks;

9 (c) Obviate revolving door accommodation promotions to successfully create a  
10 new culture of excellence in leadership and accountability in the AFP; and

1 (d) Refine and improve the rules on retirement and commissionship.

2 Towards this end, the State shall:

3 (a) Fix the tour of duty of the Chief of Staff and other officers holding key  
4 positions;

5 (b) Adjust the mandatory retirement age of Officers of the AFP;

6 (c) Raise the age of commission of officers of the AFP;

7 (d) Ensure the implementation of merit-based promotion and attrition system  
8 that will assure the AFP of a continuous pool of qualified and effective leaders; and

9 (e) Modify the Grade Distribution of Officers.

10 TITLE II

11 TOUR OF DUTY

12 SEC. 2. *Tour of Duty of Key Officers.* – The following officers holding key  
13 positions in the AFP, upon appointment, shall have a fixed tour of duty of three (3)  
14 years:

15 (a) Chief of Staff;

16 (b) Vice Chief of Staff;

17 (c) The Deputy Chief of Staff;

18 (d) Commanding General, Philippine Army;

19 (e) Commanding General, Philippine Air Force;

20 (f) Flag Officer in Command, Philippine Navy;

21 (g) Unified Command Commanders; and

22 (h) Inspector General.

23 The tour of duty of the aforementioned officers shall commence on the date the  
24 appointment is signed and shall be for three (3) consecutive years unless sooner  
25 terminated by the President: *Provided, That* those mentioned in Section 2(b) to 2(h)

1 shall not be eligible for any other position in the AFP unless promoted to the position  
2 of Chief of Staff.

3 SEC. 3. *Tour of Duty of the Superintendent of the Philippine Military Academy*  
4 *(PMA)*. – A General/Flag Officer of proven competence and academic excellence shall  
5 be appointed as Superintendent, Philippine Military Academy (PMA) and shall be  
6 exempt from the application of the maximum tenure-in-grade defined under this  
7 Act. The PMA Superintendent shall have the rank of Lieutenant General/Vice  
8 Admiral and be given a tour of duty of four (4) years unless sooner terminated by  
9 higher authority: *Provided*, That except for the position of Chief of Staff, the PMA  
10 Superintendent shall not be eligible for any other position in the AFP and shall be  
11 compulsorily retired after completion of the fixed tour of duty or upon relief from  
12 office: *Provided, further*, That no General/Flag Officer who is more than fifty-eight  
13 (58) years of age shall be appointed as PMA Superintendent.

14 SEC. 4. *Prohibition on the Extension of Tour of Duty*. – Except as provided for  
15 under Section 5 of this Act, no extension of tour of duty of the Key Officers mentioned  
16 in Sections 2 and 3 shall be allowed.

17 SEC. 5. *Tour of Duty of the Chief of Staff*. – The tour of duty of the Chief of Staff  
18 shall not exceed three (3) years. However, in times of war or other national  
19 emergency declared by Congress, the President may extend such tour of duty.

### 20 TITLE III

### 21 RETIREMENT

22 SEC. 6. *Compulsory Retirement for Military Personnel*.

23 (a) The following Officers of the AFP shall be compulsorily retired:

24 (1) Those in the grades of Second Lieutenant/Ensign (O-1) to Colonel/Captain  
25 (O-6), upon reaching the age of fifty-six (56) or accumulation of thirty (30) years of  
26 satisfactory active duty, whichever is later;

1 (2) Those in the grades of Brigadier General/Commodore (O-7) to  
2 Lieutenant General/Vice Admiral (O-9), upon reaching the age of fifty-nine (59) or  
3 the maximum tenure-in-grade as defined in this Act, whichever comes earlier;

4 (3) Those occupying a key position, as defined in Section 2 of this Act, upon  
5 completion of the fixed tour of duty regardless of age, unless promoted to Chief of  
6 Staff or who is relieved from post and is not designated to or occupying any position  
7 in the AFP Table of Organization; and

8 (4) Those commissioned under Presidential Decree No. 1908, and those  
9 appointed in the Corps of Professors upon reaching the age of sixty (60) or  
10 completion of twenty (20) years of satisfactory active duty, whichever comes later.

11 (b) An enlisted personnel shall be compulsorily retired upon accumulation of  
12 at least thirty (30) years of satisfactory active duty or upon reaching the age of fifty-  
13 six (56) years old, whichever comes later.

14 SEC. 7. *Optional Retirement.* – Upon accumulation of at least twenty (20) years  
15 of satisfactory active duty, an officer or enlisted personnel may request to be retired  
16 from military service, subject to the approval of either the President, the Secretary  
17 of National Defense, or the AFP Chief of Staff, or Major Service Commander as  
18 appropriate, as provided for in the rules and regulations to be issued to implement  
19 this Act.

20 SEC. 8. *Retirement Grade.* – Officers and enlisted personnel shall be retired  
21 one rank higher from the last rank held: *Provided,* That retirement benefits shall  
22 be based on the permanent grade last held: *Provided, however,* That this section  
23 shall not apply to those who are in active duty prior to the effectivity of this Act:  
24 *Provided, further,* That said retirees shall form part of the Reserve Force.

25  
26 TITLE IV

1 ATTRITION SYSTEM FOR THE PERSONNEL OF THE AFP

2 SEC. 9. *Definition of Terms.* – As used in this Act, the following terms shall  
3 mean:

4 (a) *Active Duty* refers to the service or duty as a commissioned officer, enlisted  
5 personnel, cadet, probationary officer, trainee or draftee in the regular force of the  
6 AFP.

7 (b) *Enlisted Personnel* refer to members of the AFP with the rank of Private up  
8 to First Chief Master Sergeant or their equivalent in the other services.

9 (c) *Forced Attrition* refers to a mode of attrition wherein an officer or enlisted  
10 personnel, who after having been considered for promotion to the next higher grade,  
11 failed to qualify on account of his/her own fault, failure or negligence or lack of  
12 individual merit, or who has completed the maximum tenure-in-grade without being  
13 promoted, is subsequently separated or retired from military service.

14 (d) *Grade* refers to the military rank of a commissioned officer and enlisted  
15 personnel. Commissioned officers, from the lowest to highest, are:

- 16 (1) Second Lieutenant/Ensign (PN);  
17 (2) First Lieutenant/Lieutenant Junior Grade (PN);  
18 (3) Captain/Lieutenant (PN);  
19 (4) Major/Lieutenant Commander (PN);  
20 (5) Lieutenant Colonel/Commander (PN);  
21 (6) Colonel/Captain (PN);  
22 (7) Brigadier General/Commodore (PN);  
23 (8) Major General/Rear Admiral (PN);  
24 (9) Lieutenant General/Vice Admiral (PN); and  
25 (10) General/Admiral (PN).

26 Enlisted personnel, from lowest to highest, are:  
27



- 1 (1) Private;
- 2 (2) Private First Class;
- 3 (3) Corporal;
- 4 (4) Sergeant;
- 5 (5) Staff Sergeant;
- 6 (6) Technical Sergeant;
- 7 (7) Master Sergeant;
- 8 (8) Senior Master Sergeant;
- 9 (9) Chief Master Sergeant; and

10 (10) First Chief Master Sergeant or their equivalent in the Philippine Navy  
11 and Philippine Air Force.

12 (e) *Officers* refer to commissioned personnel in the regular force of the AFP.

13 (f) *Primary Zone* refers to officers who are on promotable status in the  
14 uppermost portion of the promotion list equivalent to the number of declared  
15 vacancies.

16 (g) *Procurement* refers to the process of obtaining personnel through  
17 recruitment, selection, and appointment.

18 (h) *Tenure-In-Grade* refers to the allowable or maximum year given to an  
19 Officer/Enlisted Personnel in a certain grade/rank.

20 SEC. 10. *Forced Attrition of Officers.* – Officers who are subjected to forced  
21 attrition as defined in Section 9(c) of this Act shall be subsequently separated or  
22 retired from military service. In addition, officers with contractual service  
23 obligations who are recommended for separation on account of their own fault,  
24 failure or negligence, shall be required to refund the government the amount  
25 equivalent to the cost of training proportionate to the remaining period to be served  
26 as stipulated in the training contract.

1 The following are the instances of forced attrition of officers:

2 (a) *Attrition by Non-Promotion.* –

3 (1) Deferment of Promotion. – An officer in the grade of Second  
4 Lieutenant/Ensign (PN) whose promotion is deferred once shall be separated in the  
5 permanent grade the officer holds on the first day of the third month after the  
6 President shall have approved the promotion of officers recommended by the  
7 Selection Board which recommended the deferment of such an officer for the first  
8 time.

9 (2) Twice deferment of Promotion. – An officer in the grade of First  
10 Lieutenant/Lieutenant Junior Grade (PN) to Lieutenant Colonel/Commander (PN)  
11 whose promotion to the next higher grade is deferred twice shall be separated in the  
12 permanent grade the officer holds on the first day of the third month after the  
13 President shall have approved the promotion of officers recommended by the  
14 Selection Board which recommended the deferment of the promotion of such officer  
15 for the second time. This subsection applies only to officers in the primary zone of  
16 consideration because they were considered or deliberated upon by the Selection  
17 Board but failed to qualify for promotion to the next higher grade.

18 (b) *Maximum Tenure-in-Grade for Officers.* –

19 (1) Generals/Flag Officers. – The maximum tenure of officers in the grades of  
20 General/Flag Officer in the AFP are hereby prescribed as follows:

Grade	Maximum Tenure-in-Grade
General/Admiral (O-10)	Three (3) years
Lieutenant General/Vice Admiral (O-9)	Three (3) years

Grade	Maximum Tenure-in-Grade
Major General/Rear Admiral (O-8)	Three (3) years
Brigadier General/Commodore (O-7)	Three (3) years

(2) Officers. – The maximum tenure of officers in the grades of Colonel, Lieutenant Colonel, Major, and Captain, or their equivalent in the other services in the AFP are hereby prescribed as follows:

Grade	Maximum Tenure-in-Grade
Colonel/Captain (PN) (O-6)	Eight (8) years
Lieutenant Colonel/ Commander (PN) (O-5)	Seven (7) years
Major/ Lieutenant Commander (PN) (O-4)	Six (6) years
Captain/ Lieutenant (PN) (O-3)	Six (6) years

(c) *Low-Potentiality*. – An officer referred to and found by the AFP Efficiency and Separation Board as not fit for retention, lacking leadership skills, of doubtful integrity, or fails to demonstrate satisfactory performance may be separated from the military service subject to the approval of the President.

SEC. 11. *Forced Attrition of Enlisted Personnel*. –

(a) *Failure of Promotion*. – An enlisted personnel who fails to qualify or fails to satisfy any of the conditions for promotion to the next higher grade as determined by the appropriate Enlisted Personnel Promotion Board shall be referred to the concerned Review and Evaluation Board for evaluation and subsequent recommendation to the Major Service Commanders for attrition or retention. The

1 grounds for referral shall be provided in the rules and regulations to be issued for  
2 the effective implementation of this Act.

3 (b) *Maximum Tenure-In-Grade for Enlisted*

4 *Personnel.* – An enlisted personnel shall be separated or retired in accordance with  
5 the provisions of existing laws for failure to be promoted after having attained the  
6 maximum allowable tenure for the present grade except if occupying a position  
7 calling for a higher grade in the AFP Table of Organization:

First Chief Master Sergeant (E-10)	Three (3) years
Chief Master Sergeant (E-9)	Three (3) years
Senior Master Sergeant (E-8)	Three (3) years

Staff Sergeant (E-5)	Five (5) years
Sergeant (E-4)	Four (4) years

9 (c) *Low Potentiality.* – An enlisted personnel who is referred to and found by  
10 the Enlisted Personnel Reenlistment Board as not fit for retention, complacent,



1           In accordance with this Act and other pertinent laws, rules and regulations,  
2 non-commissioned officers of the Regular Force of the AFP, who have shown  
3 outstanding ability and have rendered exceptional service may be appointed in the  
4 grade of Second Lieutenant (O-1) in the Regular Force by the President upon  
5 recommendation of the Secretary of National Defense.

6           SEC. 14. *Age Requirement for Enlistment.* – Enlisted personnel shall not be  
7 less than eighteen (18) nor more than twenty-six (26) years old at the time of  
8 enlistment: *Provided,* That the AFP may offer special enlistment to an individual  
9 whose technical or skills qualifications, including excellence in athletics, are highly  
10 desirable to the organization and who at the time of enlistment is not less than  
11 eighteen (18) nor more than thirty-five (35) years old.

12           SEC. 15. *Officer Grade Distribution.* – The Secretary of National Defense shall  
13 prescribe the authorized number of officers in the active force in each grade and in  
14 each major, technical or administrative service and shall implement the gradual  
15 decrease in the number of officers in each officer rank as part of, and in line with,  
16 the Modernization Program of the AFP: *Provided,* That one (1) year after the  
17 approval of this Act, such number shall not exceed the number in each grade  
18 authorized in the Table of Organization of units of the active force distributed as  
19 follows:

20           (1) One percent (1%) in the General/Flag Officer grade based on the total officer  
21 strength authorized for the AFP or zero point one per centum (0.1%) of the total  
22 troop strength authorized for the AFP, whichever is lower;

23           (2) Six percent (6%) in the grade of Colonel/Captain  
24 (PN) based on the total officer strength authorized for the AFP;

25           (3) Twelve percent (12%) in the grade of Lieutenant Colonel/Commander (PN)  
26 based on the total officer strength authorized for the AFP;

1 (4) Eighteen percent (18%) in the grade of Major/Lieutenant Commander (PN)  
2 based on the total officer strength authorized for the AFP;

3 (5) Twenty percent (20%) in the grade of Captain/Lieutenant (PN) based on  
4 the total officer strength authorized for the AFP; and

5 (6) Forty-three percent (43%) in the grades of First  
6 Lieutenant/Lieutenant Junior Grade (PN) and Second Lieutenant/Ensign (PN)  
7 based on the total officer strength authorized for the AFP.

8 *Provided, further,* That the Table of Organization of units of the active force  
9 shall be adjusted in accordance with their respective missions and officer  
10 requirements, and shall be gradually decreased pursuant to this section and such  
11 rules and regulations as the Secretary of National Defense shall prescribe, subject  
12 to the condition that the schedule of percentage for each grade as herein prescribed  
13 shall not be exceeded: *Provided, furthermore,* That in the determination of the officer  
14 to enlisted personnel ratio, the mission requirement, capabilities, scope of  
15 responsibility, technical nature of the position and task, and equipment inventory  
16 of units shall be taken into consideration: *Provided, furthermore,* That considering  
17 the highly technical nature of the Air Force and the Navy, they shall be allocated a  
18 higher officer to enlisted personnel ratio which shall not exceed fifteen percent  
19 (15%) of the officer to enlisted personnel ratio allocated in the Philippine Army:  
20 *Provided, furthermore,* That as far as practicable, officers in the technical or  
21 administrative services such as surgeon general, chief dental service and chief nurse  
22 may be eligible for promotion to general/flag officer grade: *Provided, furthermore,*  
23 That the quota limitation provided herein shall not apply in the promotion to the  
24 rank of General/Flag Officer of reserve officers in the inactive service: *Provided,*  
25 *finally,* That if the actual number in a grade is less than the number prescribed, the  
26 difference may be applied as an increase to the number prescribed in a lower grade.

1 TITLE VI

2 GENERAL PROVISIONS

3 SEC. 16. *Competitive Categories for Promotion.* –

4 Under regulations prescribed by the Secretary of National Defense, the AFP shall  
5 establish competitive categories for promotion. Each officer whose name appears on  
6 an active duty list shall be carried in a competitive category of officers. Officers in  
7 the same competitive category shall compete among themselves for promotion.

8 SEC. 17. *Officer Lineal List.* – There shall be only one seniority lineal list for  
9 the officers of the Major Services and each of the Technical Services.

10 SEC. 18. *Prohibited Appointment.* – No retired or resigned military officer may  
11 be appointed as Secretary of National Defense within one (1) year from the date of  
12 the officer's retirement or resignation.

13 SEC. 19. *Annual Personnel Management Report.* – The AFP Chief of Staff shall  
14 submit to the Department of National Defense an accurate, comprehensive, and up-  
15 to-date Personnel Management Report, which shall include information on the  
16 number of military personnel, rank, place of designation, and list of attrited  
17 personnel, on an annual basis on or before the end of April of every year: *Provided,*  
18 That the Secretary of National Defense shall furnish a copy of the report to the  
19 Committee on National Defense and Security, Peace, Unification, and Reconciliation  
20 of the Senate of the Philippines and the Committee on National Defense and Security  
21 of the House of Representatives. The Personnel Management Report and any  
22 information contained therein shall be confidential in nature.

24 TITLE VII

25 MISCELLANEOUS PROVISIONS



1           SEC. 20. *Appropriations.* – The amount necessary for the effective  
2 implementation of this Act shall be charged to the appropriations of the Department  
3 of National Defense under the current General Appropriations Act. Thereafter, such  
4 sum as may be necessary for its continued implementation shall be included in the  
5 annual General Appropriations Act.

6           SEC. 21. *Construction and Interpretation.* – To protect the state policy and  
7 public interest as stated in Section 1 of this Act, this Act shall be given a liberal  
8 construction in favor of its provisions so as to further the accomplishment of its  
9 declared policies.

10          SEC. 22. *Implementing Rules and Regulations.* – The Department of National  
11 Defense shall formulate the rules and regulations necessary to implement the  
12 provisions of this Act within ninety (90) days from its effectivity: *Provided,* That  
13 such rules and regulations shall provide for a systematic, methodical, and efficient  
14 transition to the new retirement and separation system provided for under this Act  
15 based on the following basic principles:

16           (a) The fixed tour of duty provided herein shall apply to General/Flag Officers  
17 appointed by the President after the effectivity of this Act: *Provided,* That  
18 incumbent officers occupying key positions shall be compulsorily retired pursuant  
19 to the provisions of Presidential Decree No. 1638, as amended unless said officer is  
20 appointed to the position of Chief of Staff;

21           (b) The maximum tenure-in-grade shall only apply to officers and enlisted  
22 personnel promoted after the effectivity of this Act;

23           (c) The transition system shall allow all officers and enlisted personnel an  
24 opportunity to compete for promotions and/or complete the requirements for  
25 retirement, as may be necessary; and

1 (d) The rules and regulations shall give full respect to the services of the  
2 officers and enlisted personnel and provide for adequate separation and/or  
3 retirement benefits as may be allowed by existing laws, rules, and regulations.

4 SEC. 23. *Review and Assessment.* – The Department of National Defense  
5 shall conduct a systematic review, evaluation and impact assessment of this Act  
6 within five (5) years of its effectivity. A report shall be submitted to the Committee  
7 on National Defense and Security, Peace, Unification and Reconciliation of the  
8 Senate and the Committee on National Defense and Security of the House of  
9 Representatives within thirty (30) days after its review and assessment.

10 SEC. 24. *Separability Clause.* – If any provision of this Act is declared  
11 unconstitutional, the same shall not affect the validity and effectivity of the other  
12 provisions thereof.

13 SEC. 25. *Repealing Clause.* – Subject to the provisions of Section 22 of this Act,  
14 the following laws or provisions of laws are hereby repealed or amended:

15 (a) Sections 3 and 4 of Republic Act No. 8186, as amended, which provides for  
16 the Maximum Tenure-In-Grade and Maximum Tenure in Position are hereby  
17 repealed;

18 (b) Section 4 of Presidential Decree No. 1638, which deals with optional  
19 retirement is hereby amended;

20 (c) Sections 5(a) of Presidential Decree No. 1638, as amended by Presidential  
21 Decree No. 1650, which provides for the Compulsory Retirement for Military  
22 Personnel is hereby amended;

23 (d) Sections 10, 11, and 12 of Presidential Decree No.  
24 1638 are hereby repealed: *Provided*, That the last proviso of Section 10 shall remain  
25 in force and effect for purposes of implementation of Section 8 of this Act;

1 (e) Section 9 of Presidential Decree No. 1638, which provides for retirement in  
2 the next higher grade is hereby amended;

3 (f) Section 17 of Presidential Decree No. 1638, which provides for retirement  
4 benefits based on the next higher grade is hereby amended;

5 (g) Section 1 of Republic Act No. 9188, with respect to Officer Grade  
6 Distribution is hereby amended;

7 (h) Section 4(b) and (c) of Republic Act No. 291, as amended, which provides  
8 for the age of commissionship is hereby amended;

9 (i) Section 27 of Commonwealth Act No. 1, which provides for the age of  
10 enlistment is hereby amended; and

11 (j) All laws, executive orders, or issuances, or any part thereof, which are  
12 inconsistent herewith, are hereby repealed, amended or modified accordingly.

13 SEC. 26. *Effectivity.* – This Act shall take effect on July 1, 2022 and after its  
14 publication in the *Official Gazette* and in at least two (2) newspapers of general  
15 circulation.

**OBJECTIVES:**

- To professionalize the AFP by strengthening the merit system;
- To eliminate the “revolving door” accommodation promotions and create a new culture of excellence in leadership and accountability in the AFP by providing for fixed terms for key officials;
- To refine and improve the rules on retirement and commissionship.

**KEY PROVISIONS:**

- Provides for a fixed tour of duty of three (3) years for the following officers: Chief of Staff, Vice Chief of Staff, The Deputy Chief of Staff, Commanding General, Philippine Army, Commanding General, Philippine Air Force, Flag Officer in Command, Philippine Navy, Unified Command Commanders and Inspector General.
- Provides that the fixed tour of duty can be terminated by the President.

- Adjusts the compulsory retirement age for military personnel in the grades of Brigadier General/Commodore (0-7) to Lieutenant General/Vice Admiral (0-9), upon reaching the age of fifty-nine (59) or the maximum tenure-in-grade, whichever comes earlier.
- Provides that retirement benefits shall be based on the permanent grade last held. This provision shall apply only to new entrants.
- Provides for a system of attrition for military officers and enlisted personnel;
- Provides for a maximum tenure in grade for military officers and enlisted personnel;
- Raises the age of commission of officers to twenty-one (21) but not more than twenty-eight (28);
- Modifies the Grade Distribution of Officers in the AFP's Table of Organization;
- Prohibits the appointment of a resigned or retired officer as Secretary of National Defense within 1 year of the officer's separation from the AFP.
